

In accordance with Article 13(1) and (2) of the Regulation (EU) 2016/679 of the European Parliament and of the Council of 27 April 2016 on the protection of natural persons with regard to the processing of personal data and on the free movement of such data, and repealing Directive 95/46/EC (General Data Protection Regulation), we hereby inform you that:

- 1) **The controller** of your personal data will be the University of Agriculture in Krakow, Adam Mickiewicz Avenue 21, 31-120 Kraków, Poland.
- 2) The University of Agriculture has appointed a Data Protection Officer, whom you can contact via e-mail at iod@urk.edu.pl.
- 3) Your personal data in the form of your image may be processed for the purpose of presenting post-conference materials and promoting future editions of the conference in printed materials, publications on websites, and social media platforms, based on the consent you provide (in accordance with Article 6(1)(a) of the General Data Protection Regulation).
- 4) Granting consent for the use of personal data in the form of your image is voluntary but is a condition for including your image in post-conference materials, printed materials, and on websites and social media platforms. Failure to provide consent for the use of personal data in the form of your image will result in the inability to include your image in post-conference materials, printed materials, websites, and social media platforms.
- 5) You have the right to: a) Access your data, correct it, delete it, or restrict its processing, b) Transfer your data, c) Object to the processing – in cases and under conditions specified in the General Data Protection Regulation.
- 6) If processing is based on the consent granted to the Controller, you also have **the right to withdraw consent** at any time without affecting the lawfulness of processing based on consent before its withdrawal. The consequence of withdrawing consent for processing personal data will be the removal of photos and recordings from the Alpaca Nutrition School website and from social media profiles.
- 7) Your personal data will not be disclosed to any other recipients.
- 8) Your personal data will be processed until the conference website and social media profiles are active, or until you withdraw your consent for the processing of your image.
- 9) You have the right to lodge a complaint with the competent supervisory authority – the President of the Personal Data Protection Office – if you believe that your personal data is being processed by the Controller in violation of the General Data Protection Regulation.
- 10) Your personal data will not be processed in an automated manner, including profiling.
- 11) Your personal data will not be transferred to a third country or an international organization.
